There were six meetings of the Black Rock NRZ Board of Directors in 2017. There were many meetings of the various NRZ Standing Committees.


As part of the bylaws the NRZ supports other Black Rock groups. In 2017 the NRZ worked with the following groups:

There have been two checking accounts operated in the past by Black Rock NRZ, Inc. with Peoples United Bank. The second account was opened to receive contributions for Black Rock Farmers Market. Per request of the people running the Farmers Market, the balance in their account has been returned to the Farmers Market with a check for \$1,800 dated February 13, 2018. Previously, one other check in the amount of \$5,000 was provided to them on October 25, 2017, thus \$6,800 was received in our Peoples Account and distributed back to the Farmers Market. The \$1,000 initial startup from BRNRZ is available to be returned to the NRZ and the account closed.

V. HIGHLIGHTS of ACTIVITIES


Standing Committee 1: Business and Economic Development:

Major projects in 2017 were:

a. The Pedestrian Bridge from Black Rock to the Fairfield Metro Train Station

- b. Black Rock Commercial Village District Gateway Improvements
- c. The Wordin Avenue Park

Also, there was a privately funded major development in Black Rock involving the historic Black Rock Bank and Trust structure on Fairfield Avenue at the corner of Brewster Street, as well as another privately funded mixed use development at the corner of Fairfield Avenue and Fox Street.

Each of these projects is described below.

a. Pedestrian Bridge — Black Rock to Fairfield Metro Train Station:

In 2015, Bridgeport secured \$3.8 million in Connecticut Department of Transportation funds to build a pedestrian bridge in Black Rock over Ash Creek to the Fairfield Metro train station.

The 160-foot steel truss bridge will provide greater access for Black Rock residents to the train station. With a walkway width of 14 feet, the bridge will be a safe and convenient improvement to Bridgeport's transit oriented development.

The project also includes improvements to Fox Street (where one end of the bridge will connect) in anticipation of the increase in pedestrian and bicycle activity from Fairfield Avenue to the bridge site. The work includes reconstruction of sidewalks and curbs, along with the planting of street trees with potential to extend the existing bicycle route from Fairfield Avenue to the bridge.


In addition to the bridge structure, there will be improvements to the Creek trail. The 650 foot walkway extending Canfield Avenue creates a pedestrian greenway along current dead ends from Fox Street to Davidson Street. This will significantly increase the ¼ mile walkshed to the Fairfield Metro train station and create a scenic greenway along Ash Creek. The trail work will also eradicate existing invasive plant species and create upland meadow vegetation.

On the Bridgeport side of the bridge, there will be a gateway plaza constructed to connect to the bridge. On the Fairfield side, there will be work to help connect the wetlands walking trail and the train station.

Four community meetings were planned during the design stage to discuss the approach and get community input.

On Thursday, February 2, 2017 there was the second of the four planned community meetings at the Burroughs Community Center for public input regarding the Fox Street Bridge and for the Canfield Avenue and Fox Street area improvements. At the meeting the efforts during 2016 were discussed. In February 2018 the third community meeting was held. The design is 70% complete and the bridge is expected to complete construction in late 2020 or early 2021.

The designer's aerial rendition of the bridge, walkway from Davidson Street to Fox Street, and Fox Street improvements is shown below in Figure 1.

On July 13, 2017 there was a meeting with the people responsible for further developing the Fairfield Metro Center on the Fairfield side of the bridge. Plans for this area include apartments in about 5 buildings with a total of approximately 400 units, a Marriott Hotel, and a restaurant with outside dining. In September 2017, the mixed residential-retail development named Trademark Fairfield, adjacent to Fairfield Metro Center at 685 Commerce Drive in Fairfield, held a ribbon cutting and has since announced the opening of a Brazilian barbecue restaurant in its ground level.

b. <u>Black Rock Commercial Village District Gateway Improvements:</u>

Work continues on the \$500,000 State grant to improve the section of Black Rock along Fairfield Avenue from the Fairfield Town Line to Brewster Street. The Brewster Street and Fairfield Avenue intersection is considered the center of the Black Rock Commercial Village District.

The Black Rock Business District Gateway Improvements consist of traffic calming strategies to improve the safety for pedestrians, bicyclists, and motor vehicles, while creating aesthetic infrastructure improvements to the streetscape. Along with sidewalk and planting improvements, focal design features include integrated stormwater bioswales, pervious parking stalls, stamped concrete sidewalks, large thermo/epoxy graphics in the roadway that are representative of the neighborhood character and a treatment for an existing historic mile marker.

Attractive corner "bump-outs" will provide a traffic calming, pedestrian-safe area on each of the four curb corners on Fairfield Avenue at Brewster Street. A bump-out is an 8-foot projection at crossways into the avenue that enables a motorist to see pedestrians waiting to cross the street. This improves safety since pedestrians have a shorter crossing distance. Also, a narrowing of the roadway should slow down traffic.

A community meeting was held on July 10, 2017 at which the designer discussed the design approach and asked for inputs. The project is in the design phase; construction should begin in the spring of 2018.



c. Wordin Avenue Park:

Unused PY-41 HUD CDBG funding became available for rehabilitating a park designated "Wordin Park". Wordin Park is a triangular city park bounded by Wordin

Avenue, Spruce Street, and St. Stevens Road. The new park is across the street from the new Geraldine Clayton Magnet Academy that opened in 2017.

Benches, trash receptacles, and grills were installed. Moveable picnic tables were added to the original plan at no cost with delivery expected in the spring of 2018.

In November there was a meeting with Steve Hladun of the City's Parks and Recreation Department, a representative from Northeast Horticulture (NH), and NRZ project lead Laz Papanikolaou, and 11 trees were selected of various species. The trees were delivered the following day and planted by NH. NH also planted several hundred daffodil bulbs provided by Parks and Recreation. The Norway spruce was omitted from the plan.

It is expected that PY-41 and PY-42 funds that were left over from prior HUD CDBG years will be allocated to the NRZ and used to add a decorative fence and new handicapped accessible sidewalks to the Wordin Park project.

Mixed Use Development at Fairfield Avenue and Fox Street.

A private developer has razed multi-family dwellings which previously occupied space at the northwest corner of Fairfield Avenue and Fox Street. In their place that developer has begun construction of a mixed-use building to have ground floor retail and second floor residential units. The building is intended to capitalize on the aforementioned pedestrian bridge connecting Black Rock to Fairfield Metro Train at the foot of Fox Street.


<u>Design Review Committee</u>: This unofficial committee was established in 2016 to work mainly with Standing Committee 4 (Land Use, Development, & Historic Preservation). It is chaired by Vice President David Barbour.

The group includes members with expertise in architecture, landscape architecture, art, graphic design, and Black Rock history. In the interest of maintaining design quality in the neighborhood, the committee reviews proposed commercial developments, private and public. The focus is the evaluation of proposed designs' aesthetic compatibility with the neighborhood. When aesthetic and/or design deficiencies are identified, the committee makes recommendations for improvements. The committee worked on improvements to the proposed design of the Wordin Avenue Park. The group also reviews petitions to the zoning boards to ensure that proposed projects maintain the quality compatible with the neighborhood.

Standing Committee 2 Education:

With the \$13 million addition expanding Black Rock Elementary School to include classes for seventh and eighth grades completed in 2015, and the tear down of Longfellow School and building of the \$51 million Geraldine Claytor Magnet

Academy (GCMA) completed in 2017, the tasks of this Standing Committee are complete.

Standing Committee 3: Arts, Entertainment, and Culture:

The goal of the Arts, Entertainment, and Culture Committee is to distinguish Black Rock as a recognizable center for arts, entertainment, and culture. To that end, the NRZ is involved in expanding the neighborhood's visibility when it comes to each of these charges. At the same time it is possible for the group to establish procedures, based on industry best practices, for engaging artists of all kinds, developers, and event planners to the area.

The NRZ works closely with the Black Rock Art Guild (BRAG). BRAG meets the fourth Tuesday of each month. BRAG had many shows, one of which included poetry and art with the poems about paintings. Those interested in the events should go to the BRAG webpage and Facebook page.

In 2017 BRAG has had many shows and exhibitions in Black Rock venues. The list and extent of the art in all varieties was extensive. These include all types of visual art and also include poetry and music. Black Rock venues include the Black Rock Library, Harborview Market, Framemakers, and the Burroughs Community Center. Other venues include the University of Bridgeport and the Fairfield University Book Store.

Standing Committee 4: Land Use, Development, & Historic Preservation:

Personnel on this standing committee have been an integral part of the activities detailed above in Standing Committee 1, Economic Development. Any future issues that involve Historic Preservation will be addressed by Standing Committee 4.

This Standing Committee has completed most of their Strategic Plan tasks. It continues to monitor the Task 12 activities in the Strategic Plan Summary of Tasks, "Pursue alternative development options for 340-344 Brewster Street."

Standing Committee 5: Outreach and Communications:

The main function of this committee is to inform the Black Rock community about the NRZ, our organization and activities, and to encourage their involvement.



Standing Committee 6: Quality of Life, Environment, & Public Safety:

Quality of Life: Quality of life tasks are distributed among other Standing Committees.

Public Safety: The BRCC Public Safety Committee is chaired by Phil Blagys who sits on the boards of both the Black Rock Community Council (BRCC) and the Black

Rock NRZ. The Public Safety Committee organization and operation is described below.

Environmental Tasks: The NRZ Environmental tasks coincide with the efforts and mission of the Ash Creek Conservation Association (ACCA).

NRZ Board Member Dr. Kraig Steffen is also Vice President of the ACCA and liaises with environmental issues that are part of Standing Committee 6 tasks.

BRCC Activities Directly Related to the NRZ Strategic Plan

BRCC Safety Committee: The Safety Council works to promote the safety and security of the community by integrating the efforts of residents with the Bridgeport Police Department and elected officials. It consists of neighbors (about 300 households) from all areas of Black Rock working together in a variety of roles to enhance the quality of life that Black Rock has always enjoyed. It is organized like a block watch with Area Coordinators, Street Captains, and Block Watch Members. Crime issues are vetted through this committee for accuracy.

The Public Safety Committee met monthly in 2017, as appropriate, at the Burroughs Community Center. In addition to residents representing several sectors in Black Rock, also present were City Council members Scott Burns and Kathryn Bukovsky, State Representative Steven Stafstrom, as well as the evening and night patrol officers from the Bridgeport Police Department. A variety of public safety issues are discussed and addressed. Much of the information is keep confidential to protect sources of information.

On November 1, 2017 the Safety Committee held a community forum attended by about 40 residents. Attending from the police department were: The West End Commander, a Black Rock Patrol Officer, and Officers from Community Services, Narcotics & Vice, and others.


The Safety Committee receives, summarizes, and monitors crime statistics from the Bridgeport Police Department. This summary is used to alert Black Rock residents to crime trends so that they can take action to improve the security of their property and be alert to watch for and report crimes.

BRCC Black Rock History Committee: The BRCC History Committee met regularly in 2017 and continued its mission of promoting the history of Black Rock. Specific projects being planned include:

Black Rock Bank and Trust Renovation

The Black Rock Bank & Trust structure at the corner of Fairfield Avenue and Brewster Street is being renovated and expanded by a privately funded developer to include 15 market-rate apartments and 1550 square feet of commercial space on the first floor.

The Black Rock Community Council (BRCC) History Committee is partnering with the Fairfield Museum and History Center to restore the Robert Lambdin



mural. The mural which depicts Squire's Wharf (currently the site of the Black Rock Yacht Club) during the early years of the 19th century and was on display for many years at the Black Rock Bank & Trust Building. This important piece of Black Rock's history has been taken down due to the ongoing restoration of this building and was moved temporarily to safe storage in a climate-controlled room at the Fairfield Museum and History Center which has now assumed its ownership. Its future will require restoring the mural and determining its final location.

As part of the restoration process, the mural was shipped to Williamstown Art Conservation Center in Massachusetts to secure an estimate for the cost of its restoration which was received in the amount of \$34,000. Subsequently a second estimate was received from another arts conservation center which was significantly higher. At the time of this writing, final plans for the restoration and associated needed funding have not been determined.



- Continuing efforts to restore and maintain the Black Rock Harbor (Fayerweather) Light. The base restoration project which resulted in the acquisition of a grant for over \$400,000 has been completed. The grant and subsequent work were coordinated by the city of Bridgeport with the assistance from the BRCC. We will continue with further preservation efforts to protect and enhance this important historic structure.
- Creating and dedicating a memorial to Goody Knapp, a 17th century woman who was tried, wrongfully convicted, and hanged for witchcraft in 1653 during Connecticut's witch hysteria. The site of the hanging, Try's Field and planned location of this memorial, is on the property of the Burroughs Community Center
- Working with the Falkland Islands Museum & National Trust at Stanley to create a memorial for the Charles Cooper. The Cooper was a 19th century



packet ship built at the Hall Shipyard in Black Rock and was damaged rounding Cape Horn in 1866 but reached Port Stanley Harbor which became its final resting place. With much of the hull intact, its remains are the only full pieces of this type of 19th century wooden ship anywhere in the world. It is our intent to bring some significant piece of this vessel to Black Rock to incorporate in a lasting memorial to the Cooper.

- Continuing the project to create a digital walking history of Black Rock begun in 2015. This work entails the digitization, review, and updating of a slide presentation created in 1977 that was part of Black Rock's Bicentennial celebration.
- Creating a study guide that will identify materials available at the Fairfield Museum & History Center that relate to Black Rock's history. In September, members of our committee met with the library director at the Fairfield Museum and History Center to begin this work. We are also currently collecting materials for creating a separate research center at the Black Rock Library
- Continuing efforts to restore and maintain the Black Rock Harbor (Fayerweather) Light. The base restoration project which resulted in the acquisition of a grant for over \$400,000 has been completed. The grant and subsequent work were coordinated by the city of Bridgeport with the assistance from the BRCC. We will continue with further preservation efforts to protect and enhance this important historic structure.

VI. NRZ STRATEGIC PLAN GOALS


The Strategic Plan, in total, consists of 36 recommendations, which are summarized on Page 33 of the plan as tasks with detailed explanations on the pages immediately following. These 36 recommendations/tasks focus on key themes that came up repeatedly during the Planning Committee discussions, including: Environment and Open Space; Arts, Culture, and Entertainment; Zoning, Land Use, and Historic Preservation; Business and Economic Development; Design Review and Development Standards; Circulation, Access, Transportation and Parking; Quality of Life; and Education.

The 36 task summary is Table A-1 in Appendix A of this document.

VII. RELATED TASKS COMPLETED

Table A-2 in Appendix A lists the detailed status of all tasks and summarizes the status in categories as complete, in-process, on-going, and not applicable.

The **Strategic Plan Tasks Status Summary** section in Appendix A lists 21 tasks as completed. They are tasks 1 through 3, 5 through 8, 10 through 14, 18, 21, 26, 30 through 34, and 36 in Tables A-1 and A-2.



These tables also list 6 tasks as not applicable and will not be addressed by the NRZ. The rationale for this is given in Appendix A's **Strategic Plan Tasks Status Summary** section.

VIII. SUMMARY and STRATEGIC PLAN UPDATE

Appendix A, Table A-1 is the Strategic Plan's summary list of tasks. Table A-2 in the appendix provides a detailed status and accomplishment for each of the 36 tasks listed in the Strategic Plan.

The **Strategic Plan Tasks Status Summary** section in Appendix A states that 21 of the Strategic Plan tasks are completed and that 6 are not applicable. As explained in the appendix, the 6 classified as "Not Applicable" will not be addressed by the NRZ. Therefore 75% of the tasks are completed. Twenty-five percent (25%) are in-process or on-going.

In 2018 the NRZ will focus on the Commercial Village Overlay District (Village District) implementation with economic and cultural improvements, embedding historical themes, and extending improvements on Fairfield Avenue into Census Track 702 (Ellsworth Street to 195). This requires identifying and encouraging new development and rehabilitation of venues in keeping with the character of Black Rock to make it a pedestrian oriented and mixed-use district. The NRZ and the Black Rock community will need City, State, and possibly non-government grant support.

Also in 2018 complete the Village District Gateway Improvements project and continue toward a 2020 completion of the Pedestrian Bridge from Fox Street to the Fairfield Metro Station. Both these projects are funded by State grants.

Some organizational initiatives may be necessary:

- A community design and development review board to work with zoning to help define and ensure compliance with Village District regulations and motifs.
- Strengthen the relationship with Black Rock organizations such as:
 - Ensuring the Black Rock Business Association (BRBA) takes a prominent role in the Village District implementation and maintenance
 - Forming a partnership with the Black Rock Community Council (BRCC) whose large membership with skills needed and long history of detailed knowledge and excellent reputation in Black Rock and Bridgeport would be an asset to the NRZ activities
- Increase awareness of the Black Rock historic significance to the City of Bridgeport. This would be a benefit to the City as well as to Black Rock.

Finally, an emerging problem is a lack of parking for access to Village District venues. The NRZ and community will have to work with the City in addressing this problem.


IX. NRZ Strategy


