NRZ Leadership Committee Report: No updates, but we are doing well with all our connections and getting a lot of community support.

Kevin Howard, representing Higher Collective, the incoming dispensary business on Fairfield Ave:

• Currently the business is expected to acquire final city permits in the next 3 days, and open their business in the 3rd quarter of the year.

- The team is creating a Social Equity Plan for our neighborhood. And at the meeting we discussed potential ideas.
- Higher Collective currently has locations in Willington, Killingly, New London, Torrington, & Hamden.
- Higher Collective additionally plans to have an open house to engage and educate the community about their business and products.

Standing Committee 1: **Business Development and Land Use**: David Barbour reports:

- This committee is discussing what kind of projects they would like to take on.
- Ideas include:
 - Working on the impacts of a recent court ruling about historic properties.
 - The tree planting project
 - Attention to the adherence of local businesses to village district design quidelines
 - Addressing blight
 - Neighborhood signage that needs updating
 - Promoting businesses to those outside the neighborhood
 - Coordinate other NRZ planning efforts with traffic study in progress
 - Hold a design design charrette

Standing Committee 2: **Quality of Life**: Greg Simon and Eri Sastre provided updates on the ARPA projects:

- Nothing new to report on Dog Park
- The mural project progress was described
 - One mural location has been confirmed, the corner of Jetland & Fairfield Ave (the building that houses Roadrunner across from the municipal parking lot).
 - The next step is to identify a short list of artists that might fit each location
 - Over 50 artists are expected to submit, they are due Friday 3/15
 - We are looking for one more location in Black Rock
